PROPOSITION K.I.D.S.

Shall the Board of Education of the La Plata R-II School District, Missouri, borrow money in the amount of Three Million Two Hundred Eighty Thousand Dollars (\$3,280,000) for the purpose of providing funds for the site development, construction, equipping, and furnishing of a high school cafeteria and elementary gymnasium; to the extent funds are available, complete of other remodeling and repair improvements to the existing facilities of the District; and issue bonds for the payment thereof resulting in a debt service property tax levy of \$0.8000 per hundred dollars of assessed valuation?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to increase from \$0.0000 to \$0.8000 per one hundred dollars of assessed valuation of real and personal property.
